Terms and Conditions for Wyndham Richardson Scholarship Fund Applicants

The Wyndham Richardson Scholarship Fund provides annual Scholarships to TAFE SA students.

1. The Scholarship structure:

- The Scholarship will provide financial assistance while studying at TAFE SA;
- Scholarships are awarded to worthy applicants who, at the absolute discretion of the Trustee, have fulfilled the selection criteria;
- Each scholarship is for the academic year in which it is awarded;
- The amount of payment will be \$2,000.

2. To be eligible for a Scholarship, applicants must:

- be Australian citizens or have permanent Australian resident status;
- be enrolled in an eligible course at TAFE SA;
- complete and submit the application form provided by TAFE SA;
- attest that they are not in receipt of any other scholarship valued in excess of \$500 in total at the time of application; and
- provide evidence of:
 - a commitment to study; and
 - demonstrated financial hardship

3. Administration of Scholarships:

- Shortlisting of eligible Scholarship Recipients will be conducted by a selection Panel comprising at least three representatives from TAFE SA Staff.
- The Panel will assess shortlisted applicants and then forward recommendations to the Trustee, who will approve recipients to receive scholarships. The Trustee's decision is final.
- TAFE SA will notify all applicants, in writing, of the outcome of their application.
- All information supplied to Panel Members, TAFE SA Counselling & Inclusion staff, Administration Officers and the Trustee is treated as confidential.
- All signed Scholarship Applications will be an acceptance of the terms and conditions as set out by the Trustee; including consent to their names and personal details being provided to the Trustee for the purposes of distributing the Funds and possible invitation to social events, however, specific consent will be sought for any publicity which identifies individual Scholarship Recipients.

4. Conditions of Scholarship:

- Scholarships are paid in full as a single grant. The mode of payment is at the discretion of the Trustee.
- Scholarship Recipients who discontinue study in their Eligible Course within three months of payment of a Scholarship, for whatever reason, will be required to return the Funds to the Trustee upon the request of the Trustee, and in the amount specified by the Trustee.
